

**Explosives, Drilling/Boring and Premark**- These boxes will need to be checked if any apply to work taking place on the locate notice.

- *Explosives* Using any type of dynamite or explosives on the job site.
- **Drilling/Boring-** If drilling into the ground or boring underneath hard surfaces during excavation work.
- **Premark** When the job site has been painted, staked, or flagged to indicate where excavation work is taking place. If the job site is pre-marked this will need to be notated in the 'Instructions' field.
- *New Subdivision*-If the job site is located in a subdivision that is not on the SC811 map.

The 'Done For' field is for the name of the company or person the excavator is doing work for. If the excavator is not performing work for anyone else, their name may be listed in the 'Done For' field. <u>There</u> is a menu that auto-populates when clicking or typing into the 'Done For' field. It is not required that the company/person is selected from this list, the user can be manually typed.

## **Dates and Ticket Type Section**

In the 'Ticket Type' field the user will select the type of locate notice that will need to be processed. There are three options for the external user.

<u>Normal-</u> This is the most used locate notice when excavation work is taking place. The South Carolina state law requires a 3 full working day notice excluding the day the notice is entered, weekends and holidays to respond. It may be scheduled up to 12 full working days in advance. Be sure to make note in the 'Instructions' section of the change of the 3 full working day notice and when the excavation work is scheduled to begin. <u>Making notation of requesting the area to be marked asap or before the 3 full working days notice is against SC811 guidelines.</u>

**Design-** This type of notice is a non-excavation notice and does not cover any excavation work. On Design notice, The South Carolina state law requires a 15 full working day notice excluding the day the notice is entered, weekends and holidays to respond. A normal locate notice must be called in before any excavation work takes place. If the user's work type is "Survey" and there will be the performance of "Driving stakes or breaking ground", then the user must select "Staking/Soil Test" in the 'Type/Work' field and also submit a "Normal" notice request. If there will be no performing of "Driving stakes or breaking ground, then a design notice will need to be processed. Never suppress members on this type of notice.

<u>Subaqueous</u>- This type of notice is used when the excavation work taking place is located under a body of water; including rivers, streams, lakes, waterways, swamps and bogs. The South Carolina state law requires a 10 full working day notice excluding the day the notice is entered, weekends and holidays to respond. <u>Making notation of requesting the area to be marked asap or before the 10 full working days notice is against SC811 guidelines. Never suppress members on this type of notice.</u>

The locators/member operators are only obligated to mark requested locations within SC811 guidelines. *There is a drop-down menu that has the most requested marking instructions.* The user is not required to select an option from this drop-down menu they are able to enter customized marking instructions.






## Search Options for finding Streets, Intersections, Places, Counties and Points of Interest Search


When doing this type of search, the user can set parameters for the search to 'Near Dig Site', 'Within Map View' and 'State-Wide'. Please note that it automatically defaults to 'State-wide'.

**Note:** Searches default to Near Dig Site, but the user can expand the search area by selecting 'Within Map View' or 'State-Wide'.







<u>Street/Road</u> - To search for a specific street or road name, the user can type in part or all of the name.




**Intersection** - To search for an intersection, the user will enter the information in as a street and cross street.











<u>**County</u>** - To search for a County, type in the name of the County.</u>




<u>**Place**</u> - To search for a Place, type in the name of the Place.


<u>**Point of Interest</u>** - To search for a 'Point of Interest', type in the name or part of the name. These can be parks, cemeteries, railroads, restaurants, banks, etc. If the 'Point of Interest' that you are trying to locate is found, select it and the map will focus to its location.</u>







**Latitude/Longitude Coordinates** - To find a location using 'Lat/Lon' coordinates, type in the coordinates and then hit the 'enter' key. The location will be noted on the map with a red pushpin icon.






<u>History</u> - History tracks all of the searches the user has conducted and they can select a previous search and bring it back up again.





## Zoom In (+), Zoom Out (-)

Clicking on the Plus (+) or Minus (-) icons will let you Zoom In and Zoom Out on the map. You can also right click on the map to select the Zoom In and Zoom out options or use the wheel on your mouse for zooming.



**Note:** While using the mouse wheel to zoom in and out on the map, the user can also move the map around by holding down the left mouse button to drag the map.

#### **Show Map Information At Current Location**

Using the 'Show Map Information At Current Location' icon allows the user to hover over a location to see street, place and county information. This option can be turned on and off, and your browser will remember how the user want sets the tool. When the icon is green, that the map information will be displayed for approximately five seconds.



### **Show Map Information for Location**

Using the 'Show Map Information for Location' icon allows the user to left click on any area of the map to display street, place and county information.




#### Ruler

The Ruler lets the user measure distance in many ways. For example, it can measure the distance from one intersection to another, distance from a road into a field, and the distance along a road. It can also use the tool to click multiple points. A total footage will also be displayed. The user can click on 'Clear' to remove all measured distances and select 'Done' when finished using this feature.








### <u>Push Pin</u>


The 'Push Pin' allows the user to place multiple push pins on the map to mark locations. They also remain visible no matter how far out the user zooms from where they are placed. The user can click on 'Clear' to remove all push pins and on 'Done' when they have finished using the feature.



### **Position To Your Current Location**

The 'Position To Your Current Location' was developed for individuals using mobile devices and will not be available to in-house users.





### **Toggle Full Screen**


The Toggle Full Screen allows the user to expand the map to cover the entire screen. To return to the normal view, hit the 'Esc' button on the keyboard or click on the 'X' icon in the top right hand corner of the screen



## Toggle Base Map

The Toggle Base Map option allows the user to switch back and forth from a street view of the base map to an aerial view of the base map. Please note that all map features are available on either view.





## **Overview Map**

The Overview Map option allows the user to see an expanded overview of the area they have selected. This overview will display in the bottom left-hand corner of the map.




#### **Additional Map Features**

Several additional features are available when right clicking on the map. Right clicking on the mouse towards the bottom of the screen may affect being able to see some of the results when using this option (e.g. listing of service areas, etc).




#### Zoom To Dig Site

If the user zooms away from the dig site, they can right click on their mouse and select 'Zoom to Dig Site' to get back to where the ticket is mapped.




### Zoom To Near Street

If the user does not see the nearest street on the map, by right clicking the mouse and selecting 'Zoom to Near Street', the map will be zoom out to an expanded overview and highlight the nearest street in red. This feature only works when 'Street/Address' is selected as the 'Dig Site Type' on the locate notice.




### **Show Place**

If the user would like to know what place the address is located they can right click on the mouse and select 'Show Place'. After selecting 'Show Place' the map will zoom out to an expanded overview and outline the place the address is located in red.



### **Show Service Areas**

To display service areas on a mapped locate, the user can right click on the screen and select 'Show Service Areas'. A list of the service areas that are located at the dig site will be displayed. Once you have selected a Service Area, it will be displayed on the map.



The user can display multiple service areas. When done right click on the map and select 'Clear All From Map' so those layers will no longer be displayed.




#### <u>Search</u>

The 'Search' feature allows the user to search for service areas that were not on the original locate notice. Selecting 'Search' will take the user to the same screen that is shown when adding a member operator to a locate request.




Any of the search options can be utilized to find a specific service area. Once the service area is found, check the box to the left of that service area, and then click on 'Show On Map'. The user will be taken back to the map and the service area found in the search will be displayed in red.

# **Mapping the Work Site and Site Markers**

Once the work site or general location has been located on the map, the user will now be ready to map the work site. The Member Operators that are being notified on the locate notice are members of SC811. There are certain rules that need to be followed when utilizing each mapping tool. Each mapping tool has a different buffer zone size. The buffer zone does not indicate the area needing to be located nor do the members/locators see the map. The map is used to determine which Member Operator(s) need to be notified in the area. Keep in mind, plotting the incorrect area on the map and/or plotting the work site with the incorrect mapping tool can result in Member Operator(s) not being notified.



Please note that when the user edits or redraws a dig site using any of the mapping tools, the Save,

Cancel/Discard and Undo icons will appear. These tools allow the user to either Save the changes you made to a dig site, or to Delete/Remove those changes.



The Save icon will let the user save any changes they made to the dig site.



The Cancel/Discard icon will delete the changes the user made, keeping the original dig site

intact.



The Undo icon will let the user remove any changes they made, keeping the original dig site

intact.


#### Edit Dig Site

The Edit Dig Site mapping tool allows the user to edit the dig site map. Select the Edit icon and it will turn green. Then left click on the dig site box and it will turn blue with hash marks. The user can then start reshaping the dig site. Once they have redrawn the dig site, they can save the changes by clicking on the 'Save' icon or use the 'Cancel/Discard' and 'Undo' options to revert to the original dig site.



#### **Buffer Street or Map Feature**

The Buffer Street or Map Feature lets the user select an address range or street segment to remap the dig site. Select the Buffer Street or Map Feature icon and it will turn green. Go to the area where the dig site needs to be remapped and double click on the street segment. The new dig site will appear with blue hash marks. At this point the user can either 'Save', 'Cancel/Discard' or 'Undo' those changes.




#### **Draw Polygon**

The draw polygon tool is used to mark a large work site that the 250-foot buffer of the draw circle tool will not cover. This tool is also used when marking multiple side by side addresses.


Select the Draw Polygon tool and left click on the area where you want to start drawing your dig site. Outline the area that needs to be mapped by left clicking on points where the direction changes. When finished outlining the area, then left click twice to stop drawing. The new dig site in blue. At this point the user can either 'Save, 'Cancel/Discard' or 'Undo' those changes.





#### Draw Circle

The draw circle tool is used to mark an intersection or single point address if the property lines (grey lines) fit into the radius of coverage. The circle is a 250 ft radius. The new dig site will appear with blue hash marks. At this point the user can either 'Save', 'Cancel/Discard' or 'Undo' the changes.



#### Draw Line

The draw line tool is used when marking road, right of way, railroad track or easement. Once the user has finished drawing the segment, then double click and the new dig site will appear in blue. At this point the user can either 'Save', 'Cancel/Discard' or 'Undo' the changes.





# **SC811 Location Entry Guidelines**


#### 1. No more than 1320 ft can be marked per locate notice.

- This rule **only** applies when markings need to be done along a road, easement, right-of-way, sidewalk, or alleyway.
- This rule <u>does not</u> apply when markings need to be done on a property. However if a property is more than 1320ft by 1320ft, then the appropriate notices must be submitted to map out the dig site.
- No more than 50 feet out from the centerline of the road on both sides of the road can be marked per locate notice.



- **Example of valid marking instructions-** STARTING AT THE INTERSECTION OF CLARK ST AND STATE ST, MARK BOTH SIDES OF STATE ST GOING NORTH FOR 1320 FEET
- **Example of invalid marking instructions-** MARK BOTH SIDES OF STATE ST FROM OLD CLARK ST TO KNOX ABBOTT // TOTAL DISTANCE IS APPROXIMATELY 3500 FEET

2. Only one road can be marked per locate notice.



- <u>Example of valid marking instructions:</u> STARTING AT THE INTERSECTION OF VINE ST AND SUMMERLAND DR, MARK BOTH SIDES OF SUMMERLAND DR GOING NORTHEAST FOR 300 FT
- <u>Example of invalid marking instructions:</u> STARTING AT THE INTERSECTION OF VINE ST AND SUMMERLAND DR, MARK BOTH SIDES OF SUMMERLAND GOING SOUTH FOR 250 FT // ALSO MARK BOTH SIDES OF VINE ST GOING SOUTHWEST FROM THE INTERSECTION FOR 250 FT

#### 3. If the user requests the road to be marked from the center line of the road out:


- The maximum distance is 50 feet. If more than 50 feet needs to be marked, separate locate notices must be created following the Specific/Multiple Addresses guidelines.
- If the area requested to be marked is "marking from the center line of the road out no more than 50 feet, you would use the "Work Along A Road" guidelines.

# 4. Intersection locate notices cannot exceed 50 feet in all directions on both sides of the road(s).

- If more than a 50 foot radius of an intersection needs to be marked, separate locate notices must be issued because it would then be considered as working on separate roads
- If markings need to be done at an intersection and down one or more roads, separate locate notices must be issued one for the intersection itself and one or more locate notices for the markings needing to be done along the road(s)




- **Example of valid marking instructions:** MARK THE ENTIRE INTERSECTION OF CLARK ST AND STATE ST 50 FT IN ALL DIRECTIONS
- **Example of invalid marking instructions:** MARK THE ENTIRE INTERSECTION OF AXTELL DR AND KNOX ABBOTT DR 50 FT IN ALL DIRECTIONS// ALSO MARK BOTH SIDES OF AXTELL DR GOING NORTH FROM THE INTERSECTION FOR 500 FT
- **Example of invalid marking instructions:** MARK THE ENTIRE INTERSECTION OF LAKE MURRAY BLVD AND SAINT ANDREWS RD 200 FT IN ALL DIRECTIONS



5. If an area to be marked has been premarked with flags, paint or stakes; the area of where work will be done must still be provided.


- <u>Example of valid marking instructions</u>: ADDRESS IS 119 RAWL ST // MARK THE WHITE LINED AREA LOCATED AT THE FRONT OF THE PROPERTY
- <u>Example of invalid marking instructions</u>: ADDRESS IS 119 RAWL ST // MARK AROUND THE WHITE LINED AREA

- 6. No more than five lot numbers, five buildings or five house addresses that are side by side (on the same side of one road can be entered on one locate notice
  - A request to have the entire property or properties and including both sides of the road marked can be done as long as the area to be marked does not exceed past the property lines. If the markings need to be done along the road past the property lines(s), an additional locate notice (or locate notices) will need to be issued to cover the area along the road.




**Example of valid marking instructions:** MARK ENTIRE PROPERTIES AT 1, 5, AND 9 BROOKGREEN CT AND INCLUDE BOTH SIDES OF THE ROAD // PROPERTIES ARE SIDE BY SIDE

- A request to have up to five apartment buildings marked (as long as they are side by side on the same side of one road) There is no limit on the amount of addresses within each apartment building.
  - **Example of valid marking instructions**: MARK THE ENTIRE PROPERTY AROUND BUILDINGS A, B, C, D, E // BUILDINGS ARE SIDE BY SIDE
- A request to have properties marked that are directly side by side, but are located on two different roads will need separate locates.



• <u>Example of invalid marking instructions</u>: MARK ENTIRE PROPERTY OF 1 BROOKGREEN CT AND 231 BROOKGREEN DR 7. If an area needs to be marked around a pole, pedestal, transformer, meter, fire hydrant, etc. A <u>Detailed</u> description of where the item is located must be provided.




- <u>Example of valid marking instructions</u>: MARK A 50 FOOT RADIUS AROUND POLE #500 LOCATED ON THE RIGHT SIDE OF INKEEPER DR 100 FT SOUTH OF SUNSET BLVD
- <u>Example of invalid marking instructions</u>: MARK A 50 FOOT RADIUS AROUND POLE #500 // THIS POLE IS LOCATED ON INKEEPER DR

8. If a property and both sides of the road at a property need marking, the road marking cannot be past the property lines.



- <u>Example of valid marking instructions</u>: MARK ENTIRE PROPERTY AND BOTH SIDES OF THE ROAD AT 810 DUTCH SQUARE BOULEVARD
- <u>Example of invalid marking instructions</u>: MARK ENTIRE PROPERTY OF 810 DUTCH SQUARE BOULEVARD AND BOTH SIDES OF THE ROAD FOR 500 FEET IN BOTH DIRECTIONS OF THE PROPERTY LINES

9. When you are working with a property or job site that is divided by a county line or if the site marker buffer from any mapping tool touches a county line, a locate notice will need to be made for each county. (A notation will need to be made in the 'Directions' field informing locators that property is divided by county line).

10. When working at a corner lot and the user needs the entire property marked and both sides of the side street marked, you can mark an intersecting street at an address at a corner. You will need to put the name of the side street in the street field of the locate notice and explain in the 'Instructions' Field.



- <u>Example of valid marking instructions</u>: AT ADDRESS 110 HARVARD CT WHICH IS ON THE CORNER OF HARVARD CT AND CHASON ROAD // MARK ENTIRE PROPERTY AND BOTH SIDES OF CHASON RD AT THIS ADDRESS
- Keep in mind Chason Rd will go in the 'Street/Type' fields and Harvard Ct will go in the Intersection field
- <u>Example of invalid marking instructions:</u> AT ADDRESS 110 HARVARD CT WHICH IS A CORNER LOT WITH CHASON CT // MARK ENTIRE PROPERTY AND BOTH SIDES OF BOTH ROADS
- You will need a locate done for the entire property and both sides of Harvard Ct on a notice and then one to cover for the markings on both sides of Chason Ct

**Specific Address**- When providing marking instructions remember to be specific. For example: If the work is taking place on a specific side of the property you must make note in the marking instructions "If you are facing the property from the road".

The draw polygon tool is used to mark multiple addresses.

<u>Apartment Complexes and Mobile Home Parks</u>- This type of locate notice can be processed within the SC811 guidelines which is up to five buildings, lots, or addresses on one locate notice. They must be side by side and on the same side of the road. There is no limit on the number of apartments/units in one building. The main address should be entered in the address field and the building number(s) will need to be typed into the instructions section of the locate notice.

When mapping an apartment complex/mobile home park the entire property of the complex/park will need to marked even if work is only taking place on one particular area of the property.



The user will want to make a 1320ft by 1320ft shape around the area where the new subdivision is located. *A helpful tip, when mapping out a new subdivision is to turn the map to* 'Satellite view'. The user can sometimes see the area/lots being graded.



#### Unknown for No Name Roads, alleyways, railroad tracks, easements and right of ways-

This type of locate notice is processed when the work is taking place at a location such as: work being done on an unnamed road, an alleyway, railroad tracks, an easement or a right of way. In these situations, the word "unknown" will need to be entered in the address field. A description of the "unknown" and detailed directions of how to get to the "unknown" is required and must be provided in the directions field. An address or intersection can be used to the general area of the unknown.

#### No Name Road

- <u>Example of valid directions</u>-The unknown is an unnamed road on the northwest side of Moores Mill Rd // From the intersection of Willowdale Rd and Moores Mill Rd travel south on Moores Mill Rd for 990 ft to the unnamed road on the right.







**Latitude/Longitude locate notices-** This type of locate notice is processed when Latitude /Longitude coordinates are used to help pinpoint the work site location on the SC811 map. These coordinates are commonly used when the work is taking place in an area such as easement, right-of-way, or a new subdivision development. It is important to remember that when using the Latitude/Longitude coordinates the address still will need to be provided if applicable.


Entering Latitude/Longitude coordinates-Select the magnifying glass in the top left corner of the map, to search for coordinates.



When in the 'Search' box press the drop-down arrow and choose the 'Lat/Lon Coordinate' option.



Enter the coordinates into the 'Search' box. When searching, the map will have a red pin-point marker on top of the location of the coordinates.

<u>Work along a road-</u> This type of locate notice is processed when work is taking place along a road. A request for underground lines to be marked along a road cannot exceed 1320 feet. If the footage to be marked exceeds 1320 feet the work site will have to be broken down into multiple notices. The road name the work will take place on will go in the address field. The 1320 foot rule applies to roadways, interstates, easements and right of ways. While marking the map the footage will be displayed in increments of footage. To mark work along a road the draw line tool is used.

#### Information required when working along a road

- **Starting point-** The starting point can be entered from an intersection, a certain distance from an intersection, an address, utility poles, utility transformers or utility pedestals. If the starting point is located at a pole, transformer or pedestal directions must be provided to where the item is located.
- Where to mark- The area that needs to be marked must be specified, if the left side, right side or both sides of the road need to be marked. On a right of way or easement if the left side, right side or entire width needs to be marked.
- Total footage-The total footage that needs to be marked from starting point to stopping point.
- **Direction**-The direction of marking needs to be specified, if the road needs to be marked north, south, east or west.
- **Stopping point**-The ending point can be at an intersection, road, address, utility pole, utility transformer, utility pedestal or a specified footage. If the stopping point is located at a pole, transformer or pedestal footage must be provided from the starting point and which direction the item is located on the road.


<u>Three-way intersections</u>- When entering three-way intersections one road goes in the address field, one road in the intersection field and the additional road in the directions field. A comment that it is a three-way intersection needs to be notated.

**Example of valid marking instructions**- This is a three-way intersection // Mark the entire intersection of Mason St, Jones St, and Draper St 50 ft in all directions.



<u>Mile Markers</u>- When working is taking place at a mile marker on an interstate directions are required to the mile marker from an intersection.

The mile marker can be found in 'Exactix' by going to the search bar in the top of the left-hand corner of the map. The user will select the magnifying glass for the search bar to appear.



When searching the user will need to put the interstate number, followed by a colon with the mile marker number. For example, if searching for mile marker 75 on Interstate 26 the user would type: "I 26:75"



When selecting the correct search result the user will see the Mile Post Marker with a black pinpoint on the map as well as a red pinpoint.





# <u>Exit and Entrance Ramps</u>- When working is taking place on an exit or entrance ramp directions to the work site are required.


An exit or entrance ramp can be found in 'Exactix' by going to the search bar in the top of the left-hand corner of the map. The user will select the magnifying glass for the search bar to appear.



When searching the user will need to put the exit number, followed by a forward slash, the name of the road the interstate exits to, followed by a forward slash, then the first letter of the direction the interstate is headed. For example, if searching for exit 103 from Interstate 26 East to Harbison the user will enter: "Exit 103/Harbison Blvd/E"



When selecting the correct search result the user will see the Mile Post Marker with a green pinpoint on the map as well as a red pinpoint.



**Example of valid directions-** The unknown is the exit ramp from I-26 E to Harbison Blvd which is exit 103.

## **Using Secondary Road Number Enter a Locate Notice**

#### Secondary Road Number

When a Secondary Road Number such as a state road or county road number is given the user will still have to give the name of the actual road to be entered on the locate notice.

There is a way to look up these road numbers in Exactix.

Select the magnifying glass in the top left corner of the map, to search for coordinates.



Enter the state road number into the 'Search' box. For example if the user is searching for "State Road Number S-45-805", the user would type "State Road S 45 805" in the 'Search' field without the dashes. When searching, the road will be circled in red on the map.



The directions to the jobsite will need to include the actual name of the road, along with the state road number. For example "Ebony Ln aka State Road S 45 805".

### **Ticket Versions**

In Exactix when a primary locate notice is created it is given a locate notice number which has a "v0" behind it. The "v0" stands for "Version 0".



Each time a Secondary Action (Ticket Function) is created, the locate notice number will remain the same and a new 'Version Number' will be added.

The only action that will give a new ticket number is a Remark.

For example, if a Resend locate notice needs to be processed for ticket number 2111090149, after processing the Resend locate notice the screen will display "2111090149 v1".



#### **'Copy Function'**

The 'Copy' button that is available on existing locate notices and is utilized to make a copy of an existing locate notice without linking the numbers together in the history of the notice. It is utilized when multiple notices need to be processed or a locate notice is past the update date. Normal, Emergency, Design and Subaqueous locate notices are processed using the 'Copy' feature.



### **Secondary Actions (Ticket Functions)**

A Secondary Action (Ticket Function) is utilized when an action needs to be sent to Member Operators on an existing locate notice. When processing a Secondary Action (Ticket Function) a "**History**" will be created linking the original locate notice to the Secondary Action (Ticket Function). Additional Info, Cancel, No Show, Resend, Remark and Update locate notice are considered Secondary Actions (Ticket Functions). A Secondary Action (Ticket Function) can be processed by any person with the company that requested the locate notice or subcontractor that has been notated on the locate notice.

There are seven additional ticket functions that are able to be processed on a locate notice.

The 'Additional Info' function is used for adding a note or comment that does not change any of the pertinent information (adding directions to the job site, changing site contact information, dogs on site, etc.)



The '**No Show**' function is used when a member operator has not responded within the working days per Positive Response. The member operators have 3 hours to respond from time a 'No Show' is processed. If a member operator has responded with 'No Conflict' or 'Not in the Area of Excavation' and there are indicators of underground facilities such as a pedestal or transformer, a 'No Show' should be processed.

## <u>All member operators that have responded to the locate notice must be</u> <u>suppressed.</u>



The '**Remark'** function is used when the markings have been destroyed by weather, fading or someone else destroyed the marks. Locators have 3 full working days to respond to a remark notice. The system recalculates the new work date and time, as well as the new update and expiration dates. A remark notice can be processed any time in the life of the locate notice. *A remark notice is the only ticket function that will give the user a new ticket number*.




The '**Resend**' function is used when the locate notice has positive response stating the member operator(s) have marked the area and the crew does not see any markings, the notice can be resent. The resend function can be used if the area was not marked correctly or completely.



The '**Update**' function is used when an existing notice needs to be extended for more excavation time. This action will re-calculate a new 3 full working day notice and extend the notice for an additional 15 working days. Should any information change when updating the notice, a new normal notice will have to be created. The member operators from the mapping will refresh automatically.



The '**Cancel**' function is used when pertinent information has been changed on an existing locate notice or the job has been cancelled. All Member Operators from the original notice are notified on a cancellation notice. Cancellations can be processed at any time within the 15 full working days.



## **Work Information Section**

The 'Work Type' field is for the type of work that was being done when the damage occurred. If the user reporting the damage is unsure of the type of work that was taking place, or it is not listed, select 'Other, See Remarks (Damage Report)'. At the bottom of the form the user will put the work type information into the 'Remarks' section.

Work Type:	SIDEWALK INSTALL/REPAIR

The 'Who was doing the work?' field is for the name of the person or company that was doing the work when the damage occurred. If the user reporting the damage is unsure of this information "unknown" can be entered into this field.



The 'Date and Time of Event or Discovery' field is for the date and time the damage occurred or the date and time the damage was discovered.



The 'Location of the Damage' field is for the location where the actual damage is located.




#### **Quality Assurance Scores**

**Quality assurance (QA)** on a notice request is the systematic process of determining whether a notice meets the specified requirements and guidelines of SC811. Tickets are randomly selected. If the user scores a low score or the ticket was flagged by the evaluator, then the user will receive an email from the SC811 Support Team letting the user know they must correct the invalid ticket.
